
What is the BDPA About?

- 1) Introduces right to informational privacy
- 2) Compliance obligations for controllers and processors
- 3) Passage in 3rd Q 2019 | Proclaimed in 1st Q 2021
- 4) Extraterritorial in scope (affects processing outside •)
- 5) Informed consent required to process sensitive data
- 6) Breach notification within 72 hours

7) Fines up to BDS **\$500,000.00**

B. Key Data Protection Principles





Key Data Protection Principles

- Processing = lawful, fair & transparent
- Specified, explicit & legitimate purposes
- Data is adequate, relevant and only the necessary bits used (data minimization)
- Data must be **accurate** and **up-to-date**
- Data only identified for as long as is necessary
- Appropriate **security** applied to data


